Please note that the completion of this application does not guarantee the adoption of one of our cats. The full adoption process includes:

- 1) Completed application, verbal interview with a Hollywood Huskies representative, and an in-person home check (or photos and/or video in lieu of in-person). If approved then:
- 2) Adoption fee. 100% of the fee goes to saving another animal. The adoption fee varies by age and the specific cat.
- 3) For most adult cats, there is a one-week trial period, after which the adoption becomes permanent. If the cat is returned during the trial period, the full adoption fee will be refunded. **For kittens and high-in-demand cats, adoption fees are non-refundable** – we are still happy to take back the cat if it’s not the right fit, and we will issue a donation receipt for the amount of the adoption fee. If at any time during the life of the cat you are unable to keep him/her for any reason, you agree to return him/her only to Hollywood Huskies.
